

Authorization for the use of the image

Aigües de Barcelona undertakes to use its images only for the purpose specified, and to ensure their appropriate, pertinent and not excessive use. Likewise, Aigües de Barcelona considers that the use of the images does not constitute any illegitimate interference and does not violate their rights to honor, personal privacy and their own image.

Who is responsible for the processing of your personal data?

For what purpose will your personal data be processed? For how long?

The personal data obtained through this authorization, as well as those obtained because of it, will be processed for the purpose of disseminating and publishing the images and other personal data through the channels and means, for the period that is necessary, as it results from the terms indicated above.

At the end of the indicated period, Aigües de Barcelona will keep your blocked personal data for the period foreseen in which there may be any liability arising from the processing of personal data, or from the use of your image. When such responsibilities expire, your personal data will be permanently deleted.

Of course, you can ask us at any time to stop processing your personal data for the purpose for which you have given us your consent. To do this, you simply must send us a request to the address abdatachallenge@aiguesdebarcelona.cat. The application must have the minimum content provided for in the applicable regulations and must prove its identity. If the application does not meet the specified requirements, Aguas de Barcelona may ask you to amend it

What is the legitimacy for the processing of your data? The legal basis for the processing of your personal data is your consent.

What security measures are in place to protect your personal data? Your personal data will be treated as confidential. Likewise, appropriate technical and organizational measures have been implemented to guarantee their security and prevent their destruction, loss, illicit access or illicit alteration. When determining these measures, criteria such as the scope, contexts and purposes of the processing, the state of the art and the existing risks have been considered.

Are there other entities that may have access to your personal data to help Aigües de Barcelona with any of the tasks? Aguas de Barcelona has several suppliers who, in their capacity as data processors, assist you in the execution of different tasks related to the processing of your personal data, and the use of your image.

Aigües de Barcelona has as its sub-processor of certain services suppliers located in countries outside the European Union (EU) or, being in the EU, they share information with other entities located outside this territory.

In any case, **Aigües de Barcelona** guarantees that:

- The transfers are made to countries for which the European Commission has stated that they provide a level of protection comparable to the European one.

Is your personal data disclosed to third parties? Your personal data will be communicated to third parties, if necessary, to comply with the legal obligations that correspond in each case.

What are your rights? You have the following data protection rights:

Right	What does it consist of?
